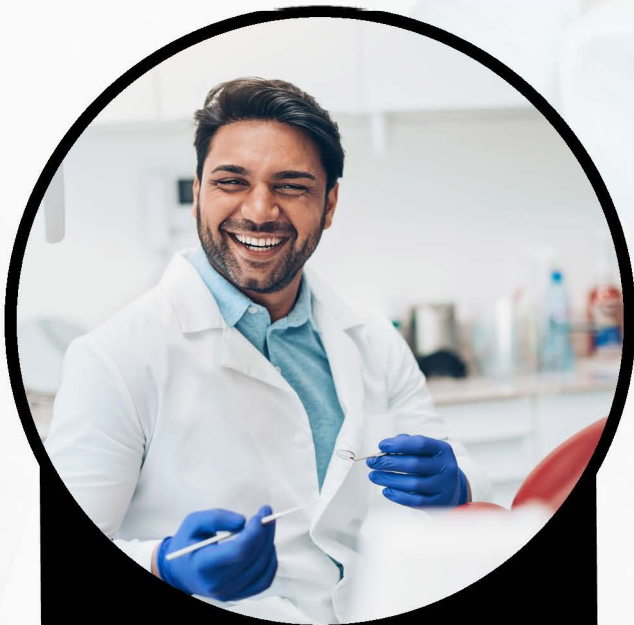
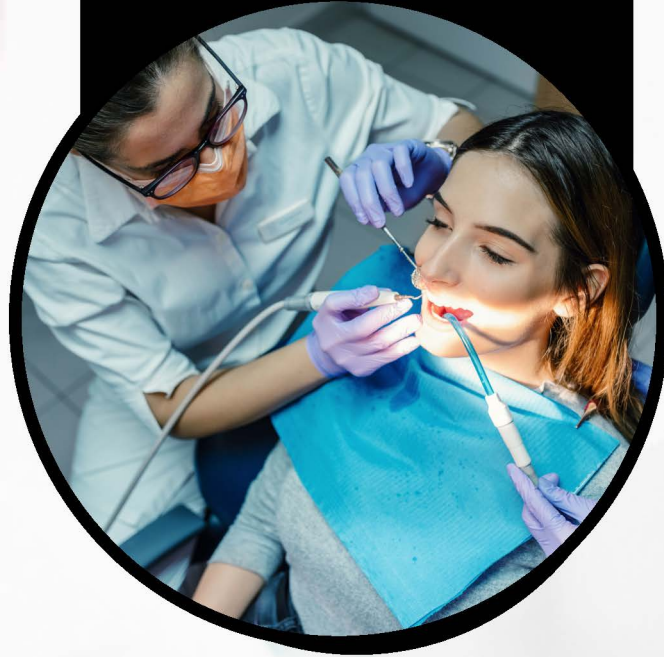

Overseas Registration Examination

Dentists with qualifications that are not acknowledged for UK registration may apply to take the Overseas Registration Examination (ORE). Once you have successfully completed the ORE, you can apply for registration. This registration permits dentists to practice in the UK. The ORE evaluates the knowledge and skills of internationally qualified dentists and consists of two components. The ORE tests the knowledge and skills of overseas qualified dentists. It is made up of two parts.

GDC ORE Registration



To apply for the Overseas Registration Examination (ORE) in the UK, you must meet the General Dental Council (GDC) eligibility requirements. We support you through the entire GDC registration journey. From verifying documents and guiding your application, to preparing you for ORE Part 1 and 2, we're with you every step of the way.

✓ 1. Recognised Dental Qualification

You must hold a primary dental qualification from a dental school outside the UK. The degree must be comparable to a UK dental qualification. You'll need to provide a Statement of Comparability from UK ENIC (formerly NARIC).

✓ 2. Clinical Experience

You must have at least 1,600 hours of clinical experience treating patients, completed during or after your qualification. Observational or simulated experience does not count. This experience must be supported by signed documents and a reference from a supervising clinician.

✓ 3. English Language Proficiency

You must prove your English language ability through one of the following: IELTS (Academic version): minimum overall score of 7.0, with no less than 6.5 in any component. Proof of dental study in English (if applicable) may also be considered in some cases.

✓ 4. Character Reference

You must submit a recent character reference from a dentist or professional not related to you. The referee must confirm your professional conduct and vouch for your character.

✓ 5. Certificate of Good Standing

Must be issued by the dental council or licensing authority in the country where you are currently or were recently registered. Must be dated within the last 3 months.

✓ 6. Identification & Passport

You need to submit a certified copy of your passport, including photo and signature pages.

✓ 7. Passport Photograph

One recent, signed passport-size photo (signed by your referee).

Frequently Asked Questions

What is the ORE and who needs to take it?

The Overseas Registration Exam (ORE) is for dentists who qualified outside the UK and the EEA and wish to register with the General Dental Council (GDC) to practise in the UK. It tests your knowledge and clinical skills against UK standards.

What does the ORE Part 1 involve?

Part 1 is a computer-based exam that tests your knowledge of clinical dentistry, human disease, ethics, and basic sciences. It consists of two papers: Multiple Choice Questions (MCQs) and Extended Matching Questions (EMQs).

What is covered in your ORE Part 1 training course?

Our Part 1 course includes structured teaching, recorded and live sessions, full mock exams, over 2,000+ questions, revision materials, and expert tutor support. We ensure you're fully prepared for the GDC exam format.

How long is the ORE Part 1 course?

The course runs over a 3-month period, with flexible access to learning materials and live sessions. You can study at your own pace while receiving regular guidance.

What does the ORE Part 2 exam involve?

ORE Part 2 tests your clinical skills and includes OSCEs (Objective Structured Clinical Examinations), manikin-based exercises, treatment planning, and a medical emergencies component.
